MINISTER'S MESSAGE

Dear Oakridge United Church,

As we look back with gratitude for all that God has done in our church community in 2023, I am mindful of how much God is doing to build a good foundation for the future here.

I am especially grateful for the ways that God has been at work, renewing our hearts and giving us a vision for our church's witness to love in our neighbourhood and in the city of Vancouver.

The Oakridge neighbourhood continues to be in a state of constant transition. With towers going up all around us, the reality of single family homes with yards is shifting into condos, townhomes, and apartments.

Our faithful presence as a house of worship, a community space, and a welcoming place for people to find belonging is a beautiful witness to God's enduring, unconditional love.

The United Church of Canada has a clear mission and vision for the future: As disciples of Jesus, we seek to be a hope-filled community, united in deep spirituality, inspiring worship and daring justice.

Some highlights for 2023:

- We raised money for First United, serving people experiencing hurt, hunger, and homelessness by participating in the 'Coldest Night of the Year' walk.
- We received 10 new members and performed two adult baptisms in 2023.
- Our children's ministry tripled its' regular attendance from 1 to 3 regular attending precious little ones.
- We walked in solidarity & love with LGBTQ2S+ folks as a Faithful Presence at the Vancouver Pride Parade.
- Our music ministry is flourishing, new choir members joining, and an increased average of 8-12 singers.

- Our Healing Touch ministry attended a refresher course and came back inspired by the Spirit to bring Healing ministry to the congregation.
- We continue to host Feast & Fallow Café, a vital and vibrant part of our neighbourhood witness to connection and belonging.
- Spiritual growth opportunities from 'Contemplative Prayer for Beginners' to our weekly Bible Study community flourished.
- We hosted Sacred Jazz events as outreach to our neighbourhood.
- Volunteers gathered over 70 full Health Kits for Powell Place Women's Shelter and other donations.
- From Potluck Parties to Christmas Carols & Crafts, we enjoyed fun and food together, around the table and making joyful noises in song!

As we look ahead to the next year, I wonder what might happen as we continue to allow God to use this community of faith to be a faithful presence in the city of Vancouver. When we meet people where they are and invite them into a place of belonging, a deep connection to wholeness and flourishing in life abounds.

I expect our 'behind the scenes work' as a church in 2024 will be somewhat logistical, organizational, and structural. We are a church firmly planted in this community: with deeply rooted spiritual practice, invitational faith-sharing, generous welcome, and a desire for reconciliation and renewal of all things. To continue to do this well, we need our shared vision to be enacted by empowered leaders, good communication, and a trust that God is at work first.

Together, when we follow the lead of Jesus, we join God in working for justice, for the common good, and for above all, love to reign. As we gather together each Sunday, I am committed to the flourishing and wholeness of all people, and welcome those seeking to join in following the way of Jesus. I am grateful to each of you for being here. This is joyful, beautiful, and good work-to reconcile and make new, all things-in love.

CHAIRPERSON'S REPORT

On January 1, 2023 the former Oakridge United Church and Wilson Heights United Church were officially amalgamated. What a joyous day that was! Since then, the Board worked diligently to culminate the records, finances, and belongings of both congregations to represent the new Oakridge United Church as a friendly, loving and supportive community of faith.

The most challenging duty we were faced with this past year was that of the issue of the Wilson Heights Church property being declared as surplus by the Pacific Mountain Region (PMR). After a long process of determining the feasibility of development of the Wilson Heights Property that was undertaken by Wilson Heights United Church, it was realized that development would not be possible without significant financial contribution from other sources.

The Board felt it was important to fight for the right of OUC to continue the utilization of this property for our ministry endeavours and set about drafting a Ministry Plan outlining how the Wilson Heights Property would be instrumental in continuing and bringing about opportunity for us to forward our ministry. Many hours of discernment, discussion, and writing were devoted to the making of our Ministry Plan and on June 27 OUC submitted its completed Ministry Plan to the PMR.

Unfortunately, even after providing our Ministry Plan along with supplemental support documentation from us and from those using the Wilson Heights Property, it wasn't until October that the PMR finally advised the Board of its decision to make the Wilson Heights Church property surplus. We as a Board were mournful and dejected with this outcome. However, we know that God has some great plans for Oakridge United Church even if we won't have the asset of the Wilson Heights Property any longer.

Some of God's great plans have already come to fruition. We have been blessed this year to welcome several new members through baptism and membership transfer. We have consistently seen new people brighten our sanctuary and become friends of OUC.

We have also had to overcome some other challenges this year. These included some issues around our technology. In this fast-changing world, keeping up with technology and keeping it running smoothly can be difficult at times. We are thankful for Elishia Beardmore, Zach Li, and Stevan Mirkovich for their assistance with this and we look forward to being able to utilize our technology to its fullest.

Another challenge this year has been maintaining the security of our building. This is an ongoing concern but the Board has been working towards some solutions to help keep our building and belongings secure.

We were happy to be able to secure some new cleaning personnel this year. A huge thank you to Steve Simms in suggesting and hiring Sean Breadner to handle our weekly cleaning needs. The building has become a cleaner, safer and more "sparkly" place to be with Sean's diligent work. Finally, we want to extend a big thank you to everyone on our Board this past year. There were some meetings that seemed to go on forever when important and difficult conversations needed to take place. Along with the challenge of facing the property surplus decision of the PMR, it made for some hard work. This was all faced with care and understanding for ourselves, the congregation, the staff, the Pacific Mountain Region, the United Church of Canada, and the path that God has set for us. The dedication of the Board of Oakridge United and the service they each give so selflessly was a true blessing to all and reflective of their love of Jesus Christ.

STEWARDSHIP, OUTREACH & PASTORAL CARE COMMITTEE

As we prepared for winter in 2023 our church and congregation got ready to do Outreach work to help people in our community less fortunate than us. Powell Place Women's Shelter is in the downtown east side and they support women in many ways. There are 52 beds in the shelter and they are always full. With everyone in the congregation's help and work Oakridge United was able to supply Powell Place Women's shelter with:

- 70 Winter Health Kits which included- toothpaste, toothbrush, bar of soap, shampoo, small Kleenex, socks, gloves, washcloth and a brush or comb.
- 11 Coats or Jackets, 31 toques, 6 extra pairs of gloves, 3 scarves and 3 sweaters.
- 6 quilts and 2 boxes of extras.

When Steve and I took the 11 boxes and 10 bags downtown the shelter staff were so grateful. Thank you all very much for helping with this important Outreach work. I know the women receiving any if these items would really appreciate them.

Among her many duties, Gracia prepares and ensures that the weekly newsletter gets out to everyone and keeps the schedule for the Sunday volunteer positions. She also secures, organizes, and keeps track of all our rentals and use of space throughout the church.

Cheryl Hutchcroft is designated as Gracia's support person and any inquiries, concerns or suggestions regarding our office support can be directed through Cheryl.

Rev. Heather Joy James and her husband, Rev. Stevan Mirkovich, have had a challenging year with viruses and medical concerns with their immediate family and their respective parents. They are always in our prayers for health and wellness for all of them.

Rev. Heather Joy James has ongoing studies with Dr. Gabor Mate who focuses on healing and addiction. She is also taking a course from Vancouver School of Theology on Supervision in Ministry. We are blessed to have a minister with these connections.

We feel the need to have more clarity and structure in our organization at the board level. Hopefully we can work toward this goal in the coming year which may enhance Heather Joy's ministry among us.




